(A \$25.00 fee for any dishonored check).

Exhibitors can check in and begin their setup on Friday, October 3 between 1:00 - 6:00 pm. Set-up on Saturday is from 7:00 – 9:00 am. The festivities begin at 10:00 a.m. and last until 6:00 p.m. Revenue packets will be distributed at check-in. Vendor information will be emailed approximately two weeks prior to the festival.

Directions – The Wharf is located at the Intersection of Hwy. 180 (Canal Road) and the Foley Beach Express. From Hwy. 161, turn left and travel approximately 4 miles.
